This Mare is booked specifically by name. The booking is valid to the mare named and may not be transferred without the consent of Sunrise Stables or the Stallion Owner. A Copy of the mare's papers must accompany this contract.

Sunrise Stables nor it's members, agents or employees shall be liable for injury, death, or disability suffered by the mare, from any cause whatsoever, while in the custody of Sunrise Stables and the owner specifically assents to such conditions and waives each and every claim for damages resulting from such injury, death or disability. Mare care ranges from \$15 a day to \$19 a day depending on the need of the mare. There is a \$250 foaling fee.

All Charges, including transportation, board, veterinarian fees as well as any and all related medicines or medical supplies, etc are to be paid monthly by the owner of the mare on or before the tenth day of the succeeding month. . If the mare fails to produce a live foal, a return privilege will be guaranteed upon Receipt of a certificate from a veterinarian. This certificate must state specifically that the mare has: a) been pronounced barren after leaving Sunrise Stables b) slipped her foal c) given birth to a dead foal; or d) given birth to a foal which failed to stand and suckle. If the stallion dies prior to getting the mare in foal, the breeding is transferable to another stallion owned by Sunrise Stables or Queenwood Stables. The Stud Fee is not refundable.

Transported semen is available and the mare owner must either provide their own equitainer or return Sunrise Stables equitainer within five days or be charged \$20 a day thereafter. The charge for collection is \$250 per collection plus the mare owner pays all transportations costs on the semen. It will be sent either Air Transport or Federal Express.

Sunrise Stables must receive payment of stud fee upon breeding of the mare. Payment must be made payable to the Sunrise Stables or Queenwood farm depending on owner of stallion.

Each mare sent to Sunrise Stables must have an identification tag on their halter or one will be made and charged to the mare owner. Each mare must be current on all required shots and possess a current coggins. Sunrise Stables reserves the right to reject any mare not in good physical condition.
